1 Briefly describe the organization's mission: PVS provides prisoners with regular, face-to-face contact with the world outside of prison to help them cope with prison life, encourage personal growth, and prepare them for successful re-entry.

4a (Code:) (Expenses \$ 62,144. including grants of \$) (Revenue \$) PVS currently has more than 300 volunteers visiting in nearly 90 federal and military prisons as they have re-opened to visiting after the pandemic. Visitors generally travel to see prisoners once a month for approximately an hour at a time, and make a two-year commitment to do so. We are actively recruiting new visitors to visit in busy prisons, and in those areas in which we do not have volunteers. All volunteers are strongly encouraged to attend monthly trainings, mostly via Zoom. PVS works to engage visitors to ensure they have a positive experience, through regular communications, email newsletters, and social Zooms. Studies show that incarcerated people who have contact with the outside world while in prison do better, both in coping with prison life and in successfully adjusting to their (See Schedule O) .
