I have enjoyed getting to know many of you through Zoom meetings, phone calls, Committee Meetings and emails. I can't wait to continue meeting each of you, as you are truly the reason PVS has been so successful in its mission to provide humanitarian visits to incarcerated individuals for over 50 years. I have open "Office Hours" each **Tuesday and Thursday from 1pm EST - 4pm EST**, where I am available to take calls to answer any questions, listen to concerns and absorb any of the priceless wisdom each of you have gained through your unique experiences visiting. I am excited to share that the October Virtual training conference is being solidified, with some innovative ideas about encouraging socialization

among Visitors, even via Zoom! I am eager to share more updates as the schedule, training topics, and closing speaker are finalized. So keep an eye out for an email with more exciting details in the next couple of months.

Also, as all of us are aware, COVID-19 impacted all areas of life as we once knew. This was especially felt in the world of Incarcerated Individuals who have experienced countless months without any in-person visits due to BOP and DOD regulations put in place to help reduce the spread of the virus in large communal living areas. As an organization, PVS created new ways to provide support to incarcerated individuals via letter writing. Recently, many facilities have begun re-opening visitation, dependent on current infection rates. We are so glad many visitors have been able to return to in-person visits and we are hoping that all facilities will be open for visitation again very soon.

In anticipation of an influx of facilities reopening visitations, we are working diligently to contact applicants who applied to become Visitors during COVID but were added to a list for follow up once visitations resumed. Once we receive confirmation an applicant is still interested in becoming a Visitor, we plan to group and prioritize interviews based on the need for Visitors and the status of visitation by location and local infection rates.

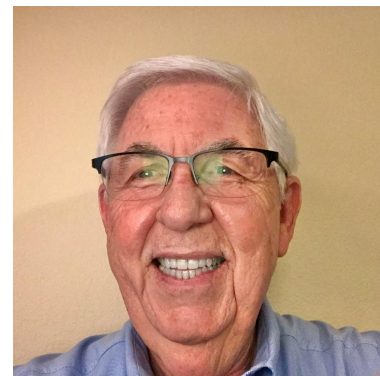
